PART I: INDIAN ECONOMY

News Features

1. **ISRO launches 104 satellites in a single mission to create world record:** India's space agency Indian Space Research Organisation successfully launched 104 satellites in a single mission, setting a world record of launching the most satellites at one go. Out of the 104, 101 are foreign satellites (96 of the US) as India seeks a bigger share of the \$300 billion global space industry.



2. India's GDP growth rate for 2015-16 revised to 7.9%: India's economy grew faster in 2015-16 than earlier estimated, which could result in slower growth in the current fiscal because of a higher base. Data released by the statistics department showed India's GDP grew 7.9% in 2015-16 against an earlier estimation of 7.6%. The statistics expected India's economic growth likely to decelerate to 7.1% in 2016-17.



3. Global PE firms invested record US\$ 6.6 billion in realty sector last year: International private equity firms invested record capital into India's real estate sector last year, but it is still just 1% of what they invested globally during the year. India attracted US\$ 6.6 billion of inflows into the property sector as against over US\$ 610 billion global capital inflows in 2016.



4. **India's January M&A and PE activity jumped 55%:** According to Grant Thornton's annual dealtracker report, India's mergers and acquisitions (M&A) and PE (private equity) activity last month rose by around 55% to US\$ 3.01 billion worth of transactions.



5. **India 2nd-largest LPG user in world:** India has become the second-largest domestic LPG (liquefied petroleum gas) consumer in the world due to the Central government's rapid rollout of clean fuel plan for poor households and fuel subsidy reforms. LPG consumption by households reached 19 million tonnes, registering an annual growth rate of 10%.

Inflation

India's annual consumer price inflation accelerated by stronger-than-expected 3.65% in Feb 2017, mainly driven by food prices, after touching its lowest level in at least five years in Jan.

Industry

Industrial production bounced back in Jan 2017expanding by 2.7% year-on-year mainly due to better performance by the capital goods segment, a barometer of investment activities. The indices of industrial production for mining, manufacturing and electricity sectors posted growth rates of 5.%, 2.3% and 3.9% in Jan. In total, nine out of the 22 industry groups in the manufacturing sector have shown positive growth during Jan 2017 on annual basis.

Foreign Direct Investment (FDI)

The sectors which have attracted maximum FDI in the Apr-Dec period of this fiscal year include services (US\$ 7.5 billion), trading (USD 2 billion), metallurgical industries (US\$ 1.25 billion), electrical equipment (US\$ 2 billion), telecommunications (US\$ 5.54 billion) and computer hardware & software (US\$ 1.81 billion). During the 9-month period of 2016-17, India attracted a total of US\$ 35.84 billion in foreign inflows.



PART II: INDIA-CROATIA ECONOMIC RELATIONS

News Features

1. **Meeting with Minister of Economy, Entrepreneurship and Crafts Minister:** Ambassador met (09/2) with Deputy Prime Minister and Economy, Entrepreneurship and Crafts Minister Martina Dalic. "Out of box" measures were discussed to enhance business cooperation.



2. **Visit of Indian Minister for Commerce and Industry:** Indian Minister for Commerce and Industry Nirmala Sitharaman, visited (14-15/2) Croatia. During the visit, she met with Croatian Minister of Economy Ms. Martina Dalic and signed (14/2) 'Bilateral Economic Cooperation Agreement'. She also interacted with a cross-section of other dignitaries including Deputy Speaker of Parliament, Zeljko Reiner, Deputy Minister of Foreign Affairs, Marija



Buric, Governor of Industrial Varazdin province, Mayor of Ludbreg, business leaders and academics. The occasion was also used to announce the establishment of the First India—Croatia Business Council (JBC) at a business dinner organized by Ambassador with participation of top Croatian and Indian business leaders, as well as academics to demonstrate linkages between business and research.

3. **Publicity about Indian State of Uttar Pradesh:** As part of Embassy's program of publicizing various Indian States a special supplement on Uttar Pradesh was taken out by the Embassy in the leading Croatian Daily "Jutarni List" (14/2), which covered features on the linkages between Croatia and UP, business and tourist opportunities in the State.



4. **Provincial Economic Outreach:** Ambassador visited Zadar, Sibenik (18-19/2), Opatija (24/2) and Rijeka (25/2) as part of provincial outreach programme and met with the Mayors, Directors of Tourist Boards, and business leaders to discuss economic possibilities.



6. **Internal meetings with business leaders:** During the month, Ambassador met with several business leaders in various fields, including medical equipment, energy, bio-diesel, etc. to discuss business opportunities.



7. **Business interview in Poslovni dnevnik:** Ambassador gave an interview to Poslovni dnevnik, business daily, (14/2) which covered wide ranging issues related to India's economic growth; India-Croatia economic relationship.

Bilateral Trade

During 2016 (for which local statistics are available) the total bilateral trade stood at Euro 111.65 million, i.e. India's exports worth Euro 100.60 million and India's imports worth Euro 11.05 million.
