PART I: INDIAN ECONOMY

News Features

1. **MoU between Sikkim and Croatia:** President of the Croatian Chamber of Agriculture, Mr. Mladen Jakopović, led a 6-member Croatian delegation at the International Conference and Fair of Biodynamic Agriculture in India, held in New Delhi on 07-09 Nov 2019. Mr. Sc. Diana Posavec, Director of Centre "Dr. Rudolf Steiner", was introduced to the latest trends in biodynamic agriculture and organic farming in the world. During the visit, Memorandum of Understanding



was signed between Croatian Centre "Dr. Rudolf Steiner" and SIKKIM IFFCO ORGANICS LIMITED (IFFCO) to promote organic biodynamic farming in Sikkim State of India.

2. India to set up 100 new airports by 2024: In order to revive economic growth in Asia's 3rd largest economy, India is planning to start 100 additional airports by 2024. With economic activity at a six-year low and probability of further slowdown looming, to revive the growth and achieve a target of making India a US\$ 5 trillion economy by 2025, Prime Minister Narendra Modi is keen to enhance infrastructure projects. To compete for investments amid global trade



tensions, Government of India cut the corporate tax rates last month, putting India on par with some of the lowest in Asia. Proposal by India's think tank also includes enhancing the number of locally trained pilots to 600 a year and double the domestic aircraft fleet to 1,200 during the period.

2. India emerged as the third largest ecosystem for start-ups: As per the Hurun Global Unicorn List 2019, with the 21 unicorns, India emerged as the third largest ecosystem for more successful start-ups right behind the China and US but ahead of Britain and Israel. In India, payment solution platform, One97 communication (US\$ 10 billion), is leading the bunch



followed by cab aggregator Ola Cabs (US\$ 6 billion), online educator Byjus (US\$ 6 billion) and travel-stay finder OYO Rooms (US\$ 5 billion). These young companies, only seven years old on an average, are the world's most exciting start-ups, leading a new generation of disruptive technology.

3. India jumped to 63rd position in World Bank's ease of doing business rankings: India is placed at 63rd position among the 190 countries in the World Bank's 'Ease of Doing Business 2020' report, 14 places higher than the last time. The country has improved its performance in six of the ten



parameters used for ranking. The improved parameters include starting a business, dealing with construction permits, trading across borders, resolving insolvency, paying taxes and

getting electricity. According to the report, 'Doing Business' analyses regulation in 12 areas of business activity in 190 economies that encourages efficiency and supports freedom to do business.

Industry

According to Indian Central Statistics Office (CSO) data, India's factory output growth, measured by the Index of Industrial Production (IIP), contracted 4.3% in September 2019 over a year ago. Slowdown was mainly due to poor performance in the manufacturing sector.

Foreign Direct Investment (FDI)

According to the Ministry of Commerce and Industry data, FDI into India grew by 28% to \$16.33 billion during the quarter April-June. Sectors which attracted maximum foreign inflows during April-June include services (\$2.8 billion), computer software and hardware (\$2.24 billion), telecommunications (\$4.22 billion), and trading (\$1.13 billion), the commerce and industry ministry data showed. India received FDI worth \$286 billion in past five years.

Inflation

Indian Central Statistics Office (CSO) data showed that the retail inflation accelerated to 4.62% in October 2019, compared with 3.99% in September 2019, largely due to a continued rise in food prices.

PART II: INDIA-CROATIA ECONOMIC RELATIONS

News Features

1. **150**th **anniversary of Mahatma Gandhi:** On the occasion of 150th birth anniversary of Mahatma Gandhi, Croatian PM Andrej Plenković and the Mayor of Zagreb, Milan Bandić unveiled (02/10) Gandhi's bust at Bundek lake. Gifting of the bust was announced by the Indian President, Ram Nath Kovind during his visit to Croatia in March 2019. Embassy's employees including the Ambassador, in cooperation with Hrvatske šume, also commemorated Gandh's anniversary by planting trees at Medvednica.



- 2. **Meeting with HBOR representatives:** Ambassador met (09/10) with representatives of Croatian Bank for Reconstruction and Development (HBOR) and discussed possibilities in expanding economic cooperation.
- 3. **Meeting with Croatian film industry:** Ambassador met (10/10) with Mr. Sergej Stanojkovski, Director of Avvantura Film Festival and discussed possibilities in expanding cooperation in film industry between the two countries including organization of India Film Festival in Croatia later this year.
- 4. **Increase of Indian tourist arrivals to Croatia:** According to data published (14/11) by the Croatian Central Bureau of Statistics (DZS), in the period Jan-Sep 2019, Croatia had a total of 60,971 Indian tourist arrivals or 7.11% more than in Jan-Sep 2018, with 135,646 overnight stays, 8.35% more than in the same period 2018.

Bilateral Trade

During the period Jan-Aug 2019 (for which local statistics are available) the total bilateral trade stood at Euro 108.44 million, i.e. India's exports worth Euro 79.64 million and India's imports worth Euro 28.80 million.
