PART I: INDIAN ECONOMY

News Features

1. **Mercedes-Benz completed 25 years of production in India:** Mercedes-Benz, a German luxury car maker marked 25 years of producing vehicles in India. In 1994, the company first started to assemble cars in India with its production site located in the Tata Motors (then known as Telco) premises before it shifted to its own unit. The company also celebrated its 10 years of new manufacturing plant at Chakan in Pune, which was inaugurated in 2009. The facility



is spread over 100 acres and employees around 730 people. Portfolio of the company produced in Pune consist of a wide range of models of Sedans, C-Class, E-Class, S-Class and CLA Coupe as well as Maybach S-Class and SUVs GLA, GLC, GLE and GLS.

2. India to see US\$ 100 billion energy investment by 2024: According to the Ministry of Petroleum & Natural Gas, India will see a huge investment of around US\$ 100 billion, over the next five years, in oil refining, pipelines, city gas distribution networks, and LNG terminals, as the world's third-largest energy consumer steps up spending to meet rising demand. Out of the total investment, US\$ 60 billion will be



used into creation of gas infrastructure such as pipelines, city gas networks, and import terminals. At present, India is the third-largest energy consumer in the world in absolute terms after the US and China, though per capita energy consumption in India is only about one-third of the world's average.

3. India as 'Guest of Honour' in the Book Fair: Mr. Sanjay Dhotre, Union Minister of State (MoS) for Human Resource Development (HRD) inaugurated the India Pavilion at the 33rd edition of International Book Fair at Guadaljara, Mexico. India was the 'Guest of Honour Country' in this book fair, and it is the first Asian country which received this honour. This fair is the biggest book fair in the Spanish-speaking world.



The National Book Trust (NBT), an autonomous body under the Ministry of Human Resource Development (MHRD) Government of India (GoI), participated as the nodal agency of the GoI in this book fair.

4. India to see US\$ 52 billion worth of M&A deals in 2019: According to the new report by Baker McKenzie, in 2019, India is expected to see M&A deals of over US\$ 52 billion, as mergers and acquisitions are expected to remain stable despite global economic slowdown. The report also showed that despite the global headwinds, India M&A is expected to remain stable in the next few years, with private investments reviving against the backdrop of a more favourable business environment.

Industry

According to Indian Central Statistics Office (CSO) data, India's industrial output contracted to 3.8% month-on-month (MoM) for three consecutive time in October against 4.3% in September. Slowdown was mainly due to contraction in the manufacturing sector followed by construction.

Foreign Direct Investment (FDI)

According to the Ministry of Commerce and Industry data, FDI into India grew by 28% to \$16.33 billion during the quarter April-June. Sectors which attracted maximum foreign inflows during April-June include services (\$2.8 billion), computer software and hardware (\$2.24 billion), telecommunications (\$4.22 billion), and trading (\$1.13 billion), the commerce and industry ministry data showed. India received FDI worth \$286 billion in past five years.

Inflation

Indian Central Statistics Office (CSO) data showed that the retail inflation rose to 5.54% in November 2019, compared with 4.62% in October 2019, largely due to a continued rise in food prices.

PART II: INDIA-CROATIA ECONOMIC RELATIONS

News Features

1. **Constitution Day of India:** To celebrate Indian Constitution Day befittingly by sharing and understanding India's rich legacy of democratic traditions, Ambassador presented a copy of the Constitution of India to Mr. Miroslav Šeparović, President of the Constitutional Court of Croatia. They discussed enhancing India-Croatia and India-EU judicial cooperation based on shared values and principles of democracy.



- 2. **Meetings with other business leaders:** During the month, meetings were held with several business leaders in sectors of media, pharmaceuticals, tourism, etc.
- 3. **Increase of Indian tourist arrivals to Croatia:** According to data published (10/12) by the Croatian Central Bureau of Statistics (DZS), in the period Jan-Oct 2019, Croatia had a total of 66,784 Indian tourist arrivals or 7.79% more than in Jan-Oct 2018, with 147,824 overnight stays, 8.71% more than in the same period 2018.

Bilateral Trade

During the period Jan-Sep 2019 (for which local statistics are available) the total bilateral trade stood at Euro 119.95 million, i.e. India's exports worth Euro 87.20 million and India's imports worth Euro 32.75 million.
