

1 billion vaccine doses administrated



On October 21, India achieved a major milestone in its vaccination program against COVID-19 as the cumulative vaccine doses administered in the country surpassed the 100-crore (1 billion) mark, resulting in celebratory events across various parts. More than 75 % of India's adult population has received at least one dose of COVID-19 vaccine, with nine states and union territories administering the first dose to all eligible people. Over 31 per cent of the country's around 93 crore adults have been administered both the doses, according to health ministry officials. In the 1 billion doses, the highest - 75 % - have received at least one dose while 31 % of the adults have been administered both the doses, according to Union health ministry. So far, all adult population in nine states and union territories - Andaman and Nicobar Islands, Chandigarh, Goa, Himachal Pradesh, Jammu and Kashmir, Lakshadweep, Sikkim, Uttarakhand and Dadra and Nagar Haveli - have received at least one dose of the Covid vaccine.

‘100 crore vaccinations not just a figure, but a reflection of India’s strength’: PM Modi



The Prime Minister noted that today many people are comparing India's vaccination program with other countries of the world. He said the speed with which India crossed the 100 crore mark, 1 billion, is also being appreciated. However, he pointed out, in this analysis the point of beginning for India is often missed. "Developed countries had decades of expertise in researching and developing vaccines. India mostly depended on vaccines made by these countries," the PM added. He said for this reason when the biggest pandemic of the century struck, various questions were raised about India's ability to fight the global pandemic. "Questions like, where will India get the money to buy so many vaccines from other countries? When will India get the vaccine? Will the people of India get the vaccine or not? Will India be able to vaccinate enough people to stop the pandemic from spreading? Were answered by achieving this feat of administering 100 crore vaccinations," PM Modi said. He stressed that India has not only administered 100 crore vaccine doses to its citizens but has also done that free of cost. The Prime Minister said at the beginning of the Corona pandemic, people were anxious that it would be very difficult to fight this pandemic in a democracy like India. Questions were also raised whether so much restraint and so much discipline work here? He said that for us, democracy means taking everyone along - Sabka Saath. The country started the campaign of 'Free Vaccine and Vaccine for Everyone'. Vaccinations were given to Poor-rich, Rural-urban alike, he said, adding that the country has only one mantra that if the disease does not discriminate, then there cannot be any discrimination in the vaccination. He said that's why it was ensured that the VIP culture of entitlement does not dominate the vaccination campaign. The Prime Minister said questions were raised that most of the people in India would not go to the vaccination centre to get vaccinated. Vaccine hesitancy remains a major challenge even today in many major developed countries of the world. But the people of India have answered it by taking 100 crore vaccine doses. He said a campaign is 'everybody's effort' and if everyone's efforts are synergized, the results are amazing. He said that the Government made public participation the first line of defence in the country's fight against the pandemic. The Prime Minister said India's entire vaccination program, born in the womb of science, has grown on scientific grounds and has reached all four directions through scientific methods. He said it is a matter of pride for all Indians that the entire vaccination program of India has been science born, science driven and science-based. The Prime Minister said experts and many agencies from home and abroad are very positive about India's economy. Today not only are record investments coming in Indian companies but new employment opportunities are also being created for the youth. With record investment in start-ups, unicorns are being made. New energy is also visible in the housing sector. He said many reforms and initiatives taken in the last few months, will play a big role in making India's economy grow faster. He said during the pandemic, the agriculture sector kept our economy strong.

PM Modi launches Ayushman Bharat Health Infrastructure Mission

Prime Minister Narendra Modi launched PM Ayushman Bharat Health Infrastructure Mission in Varanasi. While launching one of the largest pan-India schemes for strengthening healthcare infrastructure, from his parliamentary constituency Varanasi in Uttar Pradesh, PM Modi said that this mission will provide new energy and new development to India's health facilities. The Prime Minister said the country has achieved a major milestone of 100 crore vaccine doses in its fight against the corona epidemic. The Prime Minister lamented that in post-independent India, health infrastructure did not get the required attention for a very long time and citizens had to run from pillar to post for proper treatment, leading to worsening of the condition and financial strain. This led to a persistent worry about medical treatment in the hearts of the middle class and poor people, he added. Those whose governments remained in the country for a long time, instead of the all-around development of the country's healthcare system, kept it deprived of facilities, he argued. The Prime Minister said that PM Ayushman Bharat Health Infrastructure Mission aims to tackle this deficiency, Modi stated. "The aim is to strengthen the critical healthcare network from village to block to the district to the regional and national level in the next 4-5 years," he informed. Describing the initiative taken by the government under the new Mission, the Prime Minister said that there are 3 major aspects of the Ayushman Bharat Health Infrastructure Mission to address the different gaps in the health sector of the country. The first is related to the creation of elaborate facilities for diagnostics and treatment, he explained. Under this, Health and Wellness Centers are being opened in villages and cities, where there will be facilities for early detection of diseases, the Prime Minister said. For serious illness, 35 thousand new critical care-related beds are being added in 600 districts and referral facilities will be given in 125 districts, PM Modi mentioned. The second aspect of the scheme, the Prime Minister said, is related to the testing network for the diagnosis of diseases. Under this mission, the necessary infrastructure will be developed for the diagnosis and monitoring of diseases, he noted. 730 districts of the country will get Integrated Public Health labs and 3 thousand blocks will get Block Public Health Units, the Prime Minister said. Apart from that, 5 Regional National Centers for Disease Control, 20 Metropolitan units, and 15 BSL labs will further strengthen this network, he stated. The Third aspect, according to the Prime Minister, is the expansion of existing research institutions that study pandemics. Existing 80 Viral Diagnostic and research labs will be strengthened, 15 Biosafety level 15 labs will be operationalized, 4 new National institutes of Virology and a National Institute for One Health are being established, he informed. WHO regional research platform for South Asia will also strengthen this network, the Prime Minister said. "This means, through PM Ayushman Bharat Health Infrastructure Mission an entire ecosystem for services from treatment to critical research will be created in every corner of the country", he mentioned.

ISA promises \$1 trillion in global solar investments by 2030



The International Solar Alliance (ISA) has promised to achieve \$1 trillion in global solar investments by 2030. The decision was taken at the fourth general assembly of the ISA held virtually from October 18-21. According to an official press release issued by India's Ministry of New and Renewable Energy on Friday, the ISA announced a partnership with Bloomberg Philanthropies to mobilize \$1 trillion in global investments for solar energy across ISA's member countries. The two organizations will work with the World Resources Institute (WRI) to develop a Solar Investment Action Agenda and a Solar Investment Roadmap, which will be launched at COP26, it added. The meet was presided over by India's Union Minister for Power, New and Renewable Energy RK Singh. He is also the President of the ISA Assembly. US Special Presidential Envoy for Climate John Kerry delivered the keynote address. "Solar energy is the most powerful tool that the world has in its toolkit to combat climate crisis. Building a solar powered economy won't just slash carbon emissions, it'll open enormous economic opportunities," he said. According to Kerry, the ISA is unique in its focus on spreading solar to emerging economies including small island states. "So, I commend the tremendous work that every country here is doing as part of the International Solar Alliance. Solar energy is critical to our collective climate goals," he said. The European Commission Executive Vice President for the European Green Deal Frans Timmermans addressed the gathering on Wednesday. "Developing renewable energy will be the engine for our global recovery from the COVID crisis and to keep energy prices in check. It is fast becoming the most cost-effective option to generate electricity and address the needs of a rapidly growing population," he said. Delivering the presidential address, RK Singh said, "Solving the problem of energy access is more important than the energy transition. The energy transition is meaningless for those without energy. The ISA can enable energy access for 800 million people worldwide". During the assembly, two new programmes were launched: Management of Solar PV panels & battery usage waste & Solar Hydrogen programme. The new Hydrogen initiative is aimed at enabling the use of solar electricity to produce hydrogen at a more affordable rate than what is available currently (USD 5 per KG), by bringing it down to USD 2 per KG. An update on One Sun One World One Grid (OSOWOG) initiative was also discussed at the Assembly. The concept of a single global grid for solar was first outlined at the First Assembly of the ISA in late 2018. It envisions building and scaling inter-regional energy grids to share solar energy across the globe, leveraging the differences of time zones, seasons, resources, and prices between countries and regions. OSOWOG will also help decarbonise energy production, which is today the largest source of global greenhouse gas emissions. A total of 108 countries participated in the Assembly, including 74 Member Countries and 34 Observer & Prospective Countries. In addition to these, 23 Partner Organizations and 33 Special Invitee Organisations also participated. [Source](#).

Union Minister of Finance and Corporate Affairs Nirmala Sitharaman met Executive Vice President of the European Commission, Frans Timmermans in New Delhi on Friday and invited the EU to partner with India through investments in green hydrogen to harness the natural synergies in this area between the two sides. During the meeting, Finance Minister Sitharaman highlighted the strong India-European Union (EU) cooperation on trade and technology, climate and energy, digital cooperation, sustainable development and connectivity partnership, a statement issued by the Ministry of Finance said. Frans Timmermans complimented India's commendable achievements in climate action and commitment of generating 450 GW of renewable energy by 2030. He offered support of the EU in harnessing investments for successfully achieving this target. Sitharaman emphasised high priority accorded by India to climate action. Other areas include closer collaboration between India and the EU through Coalition of Disaster Resilience Infrastructure (CDRI), International Platform for Sustainable Finance (IPSF) and One Sun One World One Grid (OSOWOG) initiatives. The Kvarner Health Tourism Cluster has signed an MoU with the Indian Institute of Ayurveda

The Kvarner Health Tourism Cluster has signed a business cooperation with the Indian Institute of Ayurveda, an autonomous organization under the Ministry of AYUSH of the Republic of India. This new business collaboration, signed on Wednesday, October 6, is the result of a shared desire to strengthen and further develop collaboration between the Cluster and the Indian Ministry in the study of traditional medical systems, especially in the area of Ayurveda. Academic cooperation between the two sides will include participation in research, lectures, workshops and other such activities on Ayurveda, as well as the development of academic standards for Ayurvedic education in Croatia. First Visit of Director General of Indian Council For Cultural Relations to Croatia: Croatia, India 'wish to intensify bilateral relations'

Croatia and India wish to improve bilateral relations, notably cultural cooperation, Croatian Prime Minister Andrej Plenkovic and Indian Council for Cultural Relations Director General Dinesh Patnaik said on 25th October. They met in Zagreb to discuss the development of the relations between the two countries, notably through the 2019-22 cultural exchange programmes between the two governments, and preparations for an International Roma conference to take place in Zagreb in April 2022, the government said in a press release. PM Plenkovic said he wished for the bilateral relations to intensify, adding that the EU-India strategic partnership which began in 2018 and the future agreements currently being negotiated created better conditions for deepening economic cooperation between Croatia and India. Patnaik said India was planning numerous activities to bring its rich cultural legacy closer to Croatian citizens. PM said he was pleased the international Roma conference was being prepared by the Croatian and Indian governments together, adding that the Croatian government pursues a policy of inclusion towards all ethnic minorities. Croatian MP Veljko Kajtazi, who attended the meeting, said a lot had been done to improve the status of the Roma community in Croatia and in implementing the Roma Operational Programme. The common priority is to continue to work on even better Roma integration in Croatian society, he added.

News on India

The Blue Tigers lifts the SAFF Championship title for the eighth time after goals from Sunil Chhetri, Suresh Singh and Sahal Abdul Samad helped them defeat Nepal 3-0 in the SAFF Championship 2021 final. The South Asian Football Federation Championship, commonly known as SAFF Championship, is the main international association football competition of the men's national football teams governed by the South Asian Football Federation. India bagged their eighth SAFF Championship title with a 3-0 win over Nepal on 13th of October at the National Football Stadium in Male, Maldives. This was the Sixth time that the **Blue Tigers managed to win a game since Croatian soccer legend Igor Stimac became the head of the team two years ago in May 2019.**



India reopens to foreigners on tourist visa from 15th October, only chartered flights allowed for now India begins granting tourist visas to foreign travelers intending to visit the country on chartered flights from 15th of October, while visas for those on regular flights will be granted from November 15. According to the notifications issued by the Union home ministry, the latest orders are a sign that the country is gradually relaxing its coronavirus disease (Covid-19) restrictions and reopening its frontiers, albeit with sufficient and necessary precautions, in view of the easing overall pandemic situation. The decision was taken “after considering various inputs” which suggested that fresh tourist visas be granted to foreigners coming to India. Flush with funds in a year of unprecedented investments, and chasing the next level of growth, many of them are in a mad rush to hire the best talent available. Indian startup unicorns are on an unprecedented hiring spree, executives of various firms told us. This was borne out by two studies. According to a study by EMA Partners in September, India has 70 unicorns which have hired almost 1.5 lakh executives in the past three quarters. A large proportion of the hiring, up to 70%, will be for technology roles. Full stack developers, data scientists, solution architects and principal engineers are among those in high demand. According to their executives: CRED has hired 350 people since the start of the pandemic and currently has more than 500 employees. It plans to hire another 300 people in the coming months. Vedantu is looking to hire 1,000 people over the coming months as it plans to debut in international markets in the next 12-15 months.



India is the 5th largest market in terms of aircraft passengers (domestic and international). A rising proportion of middle-income households, healthy competition amongst Low-Cost Carriers, infrastructure buildup at leading airports and supportive policy framework will see India become the 3rd largest aviation market in the world by 2024. With the air passenger traffic projected to increase, the Indian aviation industry is on a high-growth path. To satisfy the current and projected rise in demand for commercial air travel, Indian airlines have placed large orders for aircraft. The nation's airplane fleet is projected to quadruple in size to approximately 2500 airplanes by 2038. Currently, the country has 128 operational airports including 29 international, 89 domestic, and 10 custom airports. To meet the growing demand for air travel in India, it has become imperative to increase the capacity of airport infrastructure. The projected upsurge in air travel in India would require more aircraft usage, thus, in turn, igniting the demand for Maintenance, Repair & Overhaul (MRO) services. The Indian Civil Aviation MRO market, at present, stands at around \$900 mn and is anticipated to grow to \$4.33 bn by 2025 increasing at a CAGR of about 14-15%.


Mahatma Gandhi's 152nd birth anniversary

 Mrs. Marijana Janjic, PhD, Professor of Indian linguistic, talked about the preservation of linguistic diversity in India.





