EU-India: Joint Press Release on Fourth Strategic Partnership review meeting in New Delhi



India and The European Union held their fourth Strategic Partnership Review Meeting on 08 May in New Delhi. The Indian side was led by Shri Sanjay Verma, Secretary (West) and the EU side was led by Helena König, Deputy Secretary General for Economic and Global Issues, European External Action Service. The Meeting reviewed the entire gamut of the India – EU bilateral relationship detailed in the 'India-EU Strategic Partnership: A Roadmap to 2025' agreed upon during the 15th India – EU Summit in 2020. India and The EU went through an extensive review of their successful bilateral relationship also in the context of the meetings organized by India under its G20 Presidency.

Startup scene India-Croatia

Google leads funding round for Indian space startup Pixxel

Alphabet Inc's (GOOGL.O) Google is leading a \$36 million funding round for Bengaluru-based Pixxel, a satellite-image startup, in the first major investment in the Indian space sector since the government launched its privatisation policy in April. Pixxel, founded in 2019, is building a constellation of satellites that have the ability to identify mineral deposits or the productivity of crops by analysing the spectral signature of an image. Miner Rio Tinto Ltd (RIO.AX) and Australian agritech company DataFarming are clients, Pixxel said. The startup has raised more \$71 million from investors including Accenture PLC (ACN.F). Pixxel did not specify the valuation it reflected. Google said it had made the investment in Pixxel through its India Digitalisation Fund, which focuses on investment in India-based startups. Founder and Chief Executive Awais Ahmed said Pixxel would be "the most valued space tech company in India after this investment".

That had been rocket and launch provider Skyroot Aerospace, valued at an estimated \$163 million, according to Tracxn, which tracks startups. "We work with satellite data and Google does a lot of work around that with agriculture and environment," Ahmed told Reuters. "They also have Google Earth ... so a combination of that led to them seeing a benefit." Pixxel is among the many private companies looking for a fillip since India opened the space sector, encouraging startups to deliver broadband services like Starlink and to power applications like tracking supply chains. The government announced its private-sector space policy framework in April. The funding comes at a time when startups globally have struggled to raise funds. Space startups, in particular, have come under pressure after the bankruptcy of Richard Branson's Virgin Orbit launch company. Ahmed said the funding would be used to build out its satellite network. Pixxel is readying six satellites for launch next year to add to the three it has now and looking to hire more engineers for its analytics. Ahmed has said he was inspired to launch a space startup from a visit Elon Musk's SpaceX as part of a student competition to build a demonstration "hyperloop" transport pod.

He and co-founder Kshitij Khandelwal set out to build an AI model that could use satellite data to predict crop yields, detect illegal mining and track natural disasters. They launched Pixxel when they concluded existing commercial satellite images did not provide enough detail. Pixxel's satellites take in and analyse a wide spectrum of light instead of just assigning primary colours to each pixel, a technology known as hyperspectral imaging.

Amazon's AWS to Invest \$13 Billion in India



Amazon's cloud computing division, Amazon Web Services (AWS), has announced plans to invest \$13 billion in India by the end of the decade, reinforcing its commitment to tap into the surging demand for cloud services in one of Asia's fastest-growing economies. This substantial investment is in addition to the \$6.5 billion that Amazon has already poured into the Indian e-commerce market. The fresh investment will primarily be directed towards expanding and strengthening the cloud infrastructure in India. Furthermore, this initiative is expected to create over 100,000 full-time job opportunities annually. With this additional investment, Amazon's total planned expenditure in India will reach approximately \$16.4 billion by 2030.

Currently, Amazon operates two data centres in India, with one located in Mumbai and another in Hyderabad. These centres have been instrumental in delivering a comprehensive range of services offered by the cloud platform, which encompasses over 200 features, including storage, networking, and artificial intelligence capabilities.

Amazon's latest move aligns with India's intensified efforts to attract substantial investments in the digital domain to meet the escalating demand for data storage and services from both corporate entities and government bodies. Market intelligence provider IDC predicts that India's public cloud services market will exceed \$13 billion by 2026, with a projected compound annual growth rate of 23.1% between 2021 and 2026.

Moreover, the country's broader technology sector has recently attracted notable investments. Networking equipment manufacturer Cisco Systems announced its plans to commence manufacturing operations in India, aiming to diversify its global supply chain. Additionally, Foxconn, a prominent supplier to Apple Inc., intends to invest \$500 million in establishing manufacturing facilities in the southern state of Telangana.

India claims gold at Men's Junior Asia Cup 2023

From 23 May to 1 June 2023, the best young Asian men's hockey teams went head-to-head in the Men's Junior Asia Cup Salalah 2023, competing for the gold medal and the final three spots up for grabs in the upcoming FIH Junior Hockey Men's World Cup 2023, to be played in Kuala Lumpur, Malaysia. The finals saw India's win over Pakistan. A cagey and close encounter was edged by India who took a 2-goal lead into half-time and while Pakistan struck back once in the third quarter, India would hold their nerves to claim a 2-1 victory and the gold medal. Korea won the bronze medal match against Malaysia by a 2-1 margin. With the results India, Pakistan, Korea and Malaysia (hosts) have qualified for the FIH Hockey Men's Junior World Cup 2023.

#KIUG2022

Khelo India University Games (KIUG), is a national level multi-sport event held in India, where athletes from universities across the country compete in different sports disciplines. The Khelo India University Games 2023 concluded on June 3 with Panjab University reclaiming the title after three years. Panjab University, who won the inaugural Khelo India University Games title back in 2020, topped the KIUG 2023 medals tally with 26 gold, 17 silver and 26 bronze medals (total - 69 medals).

Amritsar's Guru Nanak Dev University came in second in the overall championship race with 24 gold, 27 silver and 17 bronze (total 68 medals). The team with the most gold medals wins the team title. Last edition's champion Jain University had to be content with the third position in the KIUG 2023 medals tally with 16 gold, 10 silver and six bronze medals (total - 32). However, the most decorated individual male and female athletes at KIUG were both from Jain University.

NEWS ON INDIA

Indian Ports Achieve Remarkable Turn-around Time, Boosting Efficiency: World Bank Report. The Ministry of Ports, Shipping, and Waterways announced that Indian ports have achieved a remarkable performance in improving their "turn-around time," surpassing several nations, as revealed in the latest Logistics Performance Index (LPI) 2023 study conducted by the World Bank. This significant development highlights the enhanced efficiency and productivity of Indian ports. Reacting to the news, Prime Minister Narendra Modi expressed his satisfaction with the performance of Indian ports and emphasized that India is well on its way to establishing itself as a hub for commerce and logistics, driven by the ambitious port-led development.

India has emerged as the 2nd Largest Producer of Crude Steel in the world: Union Minister of Steel & Civil Aviation Mr. Jyotiraditya M. Scindia. Union Minister of Steel and Civil Aviation, Mr. Jyotiraditya M. Scindia, addressed a news conference at Rajiv Gandhi Bhawan, New Delhi, on the theme "9-years of Government's "Seva, Sushasan and Gareeb Kalyan" focused on the Steel sector. The Minister began his speech by emphasising the importance of the steel industry in maintaining the country's Pragati (growth) and Vikas (progress). "India currently ranks as the World's 2nd largest Producer of Crude Steel, surpassing Japan in 2018," the minister stated, noting India's steel industry's extraordinary progress. By decreasing imports and adding approximately 60 million tonnes (MT) of crude steel capacity, the government policies for the steel sector helped the country save US\$ 4.21 billion (Rs. 34,800 crore) in foreign exchange. From 109.85 MT in 2014-15 to 160.30 MT in 2022-23, India's steel capacity climbed 46% to 160.30 MT, he said, adding that total production increased 42% from 88.98 MT to 126.26 MT. During the same period, per capita steel consumption increased by 43%, rising from 60.8 kg to 86.7 kg.

India's internet economy is expected to hit US\$ 1 trillion by 2030, says the report. According to a report released by Google, Temasek, and Bain & Company titled "The e-Conomy of a Billion Connected Indians," India's Internet economy is expected to increase from US\$ 175 billion in 2022 to US\$ 1 trillion by 2030. The report, which was based on investor and consumer surveys, stated that digital consumption is fuelling growth in important Internet economy sectors like e-commerce, online travel, food delivery, and ride-hailing. The share of the Internet economy in India's technology sector will increase from 48% in 2022 to 62% in 2030. Further, it was claimed that it will also make up 12-13% of India's GDP, up from 4-5% in 2022. It ascribed the rise in the internet economy to India Stack's success, increased digital demand in tier 2+ cities, and the digitization of conventional enterprises. In the upcoming years, expansion of the digital economy will also increase India's appeal as a place to invest. Three out of five investors, according to the study, anticipate an increase in deal activity in India during the next 2-3 years. Most investors also stated that, over the next 5-7 years, they intend to devote more than 75% of their capital to digital investments. Investors are most interested in software-as-a-service (SaaS), fintech, and B2C/B2B e-commerce sectors, according to the report.

Spice exports have doubled in the last nine years, says Mr. Piyush Goyal. India's spice exports have doubled over the past nine years, from US\$ 216.2 million (Rs. 1,778 crore) in 2013-14 to US\$ 485.8 (Rs. 3,995 crore) in FY23, informed Mr. Piyush Goyal, the Minister of Commerce & Industry, Consumer Affairs, Food & Public Distribution, and Textiles. In FY23, approximately 165 countries imported spices from India, according to data from the Ministry of Commerce. Bangladesh, the UAE, Morocco, the Netherlands, Germany, and the US are a few top international markets for Indian spices. With 15.31 lakh tonnes of spices produced in 2021-22 and 2022-23, India is the world's top producer of spices, as per the Spice Board of India, a statutory organisation under the Union Ministry of Commerce and Industry.

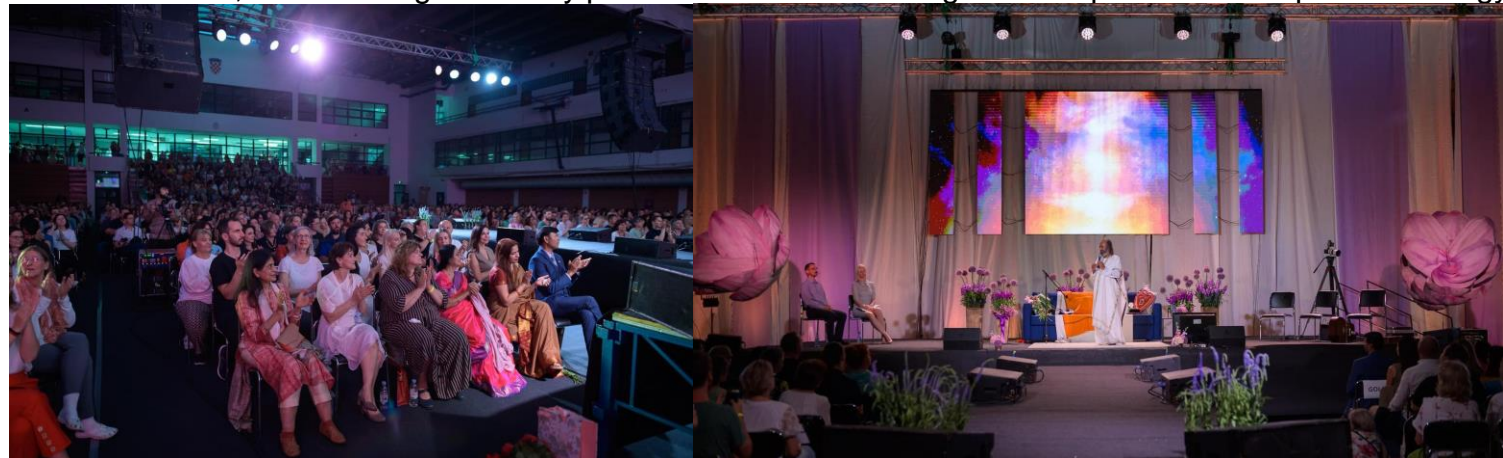
